## Metal Assault Cheat Codes

The evidence showed that the defendant committed a burglary by breaking into the victim's house, committing a theft by taking the victim's television set, and committing an aggravated assault by shooting the victim in the head with a handgun. *Fleming v. State*, 277 Ga.App. 667, 627 S.E.2d 563 (2006). An eyewitness to an aggravated assault and armed robbery testified that the defendant, a guest in a motel room, pointed a handgun at him, threatened to kill him and his mother, and then ran out of the motel room. The victim testified that he feared for his life and that the defendant broke into his mother's motel room and beat and robbed him with the gun. See *Price v. State*, 270 Ga. App. 718, 609 S.E.2d 649 (2005). Regarding aggravated assault, only one of the victims testified that there were two assailants. The facts of this case were similar to *State v. Collazo*, 221 Ga.App. 567, 571-572(1), 571 S.E.2d 788 (2002), in which it was the defendant and his brother who grabbed a pair of scissors from a store, fled the scene of the incident, and were arrested. As to the victim's testimony, it was not error to allow the jury to decide whether the victims' testimony was credible. *Dykes v. State*, 299 Ga.App. 875, 881(5), 685 S.E.2d 448 (2009). A defendant is the "champion of his own cause" and has the right to have the jury pass on the witnesses, the weight, and the credibility of the testimony, and if it does not believe a witness, it may disbelieve anything he says. (Citation and punctuation omitted.) *Smith v. State*, 281 Ga.App. 26, 29(1)(a), 635 S.E.2d 804 (2006).
